



Membership application form – guidance

Please read these notes before filling in your application form.

A. About you

Please provide as much contact information as possible, and don't forget to indicate which address we should send invoices to.

B. Your career

Use this checklist to make sure you've given us all the information we need:

- details of your current and previous employment, with dates
- your employers' names and addresses
- details of your health and safety responsibilities with each employer
- your current job description (if you're employed), signed by your employer

If we offer you Technician or Graduate membership, we may need to contact your current or former employers for more information. We won't do this without asking you first.

C. Your qualifications

When we receive and approve your application, we'll automatically enrol you as an Affiliate member. If you don't have health and safety qualifications and you're not planning to progress towards Chartered status, you can stay at Affiliate level and you needn't fill in this section.

In order to qualify for Technician or Graduate membership, which lead towards Chartered status, you'll need a health and safety qualification accredited by us. Your pack contains lists of courses accredited for Technician and Graduate membership. We also look for a minimum level of experience in a health and safety role. This can be in a full-time, part-time or voluntary role.

If you have a higher-level qualification that's not on our list of accredited courses but includes at least 60 per cent health and safety content, we will consider accepting it as a cognate degree.

Please tell us in this section about any health and safety qualifications you've got and the year you obtained them. We may contact the college or university you studied at for more information about the course. We'll ask you to send your certificates later on, when we outline the route to Chartered membership that best suits you.

If we offer you Graduate status, we'll ask you to enrol on our Initial Professional Development (IPD) scheme at a one-off cost of £100. You have to complete your IPD cycle to move towards Chartered status.

If you want to maintain Technician, Graduate or Chartered status, you'll need to commit to following our Continuing Professional Development (CPD) scheme. We'll tell you about this when we discuss your membership status.

D. About your job

E. Specialist groups

Each branch has members from all sectors of industry, so getting involved is an ideal way to broaden your knowledge. G. Your subscription payment

Choose whichever payment method that suits you. Your membership will be due for renewal one year after we accept your application – we'll send you a reminder in advance.

The basic fee of £125 (non-refundable) covers the joining fee plus a year's membership as an Affiliate Member. If you want to join more than one specialist group, please add £10 per extra group. If you'd like to subscribe to our twice-yearly academic journal, *Policy and Practice in Health and Safety*, please add £20.
